New Business - Supervisor Matthews moved that Marilyn Baumgras purchase address numbers and install them for the Township Hall. Treasurer McGarry seconded. All in favor.

The Board of Commissioners have requested input on a Planning Commission matter which will be discussed on June 20 at 7PM. Trustee Koerner made a motion to instruct our delegate to vote for one building site per 40 acres as has been past practice, not as currently written. Supervisor Matthews seconded. All were in favor.
