

Sciota Township Board Meeting – August 8, 2011 (draft minutes)

The August 8, 2011 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Koerner, Treasurer Schuman, Trustee Thelen and Trustee Allen. Public present was Floyd Koerner, Jr., Pam Schuman, Ed Buskirk and Deputy Matt Davis.

The minutes of the July meeting were passed on a motion by Schuman and seconded by Thelen.

Koerner moved to accept the treasurer's report and place it on file. Allen seconded the motion and it passed.

Sheriff report: Deputy Davis reported there have been a lot of B & E's in this area, mostly in the daytime. They think they have an idea of the vehicle involved.

Emergency Services: There have been 299 runs so far this year.

Board reports: Matthews reported a request from SATA for \$5,254.71 for the coming year. Board is not interested. He also had a letter from MTA on their workman's compensation plan. We are not interested at this time. Information on upcoming 'On The Road' meetings was presented. We have until next month to decide on attending. Koerner had none except those already presented. Schuman explained the new law on tax collection dates and when he had to be home. He also told of the 'Writing & Adopting Ordinances' class he attended. It was very informative. Allen told of some holes in Garrison Road.

Planning Commission: Thelen explained a change in our land division ordinance suggested by the planning commission. It is in Section 2 Purpose, last sentence –
.....prior review and approval of all (including exempt splits) land divisions. Matthews moved to approve the suggested change and Schuman seconded. All were in favor. We will look at the fee schedule next month.
