## Sciota Township Board Meeting – March 9, 2015

(draft minutes)

The March 9, 2015 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm. The Pledge of Allegiance was given by all. Tax receipts: This was discussed and Matthews requested that the treasurer decide how to best achieve this and present it to the board next month for action.

Schuman moved to allow himself to attend a workshop on Township Board Roles and Relations and to send the check right away to meet the early deadline. Koerner seconded it and the motion passed on an all yes roll call vote.

Thelen moved to pay bills and Reed seconded the motion. It passed.
