

## **Sciota Township Board Meeting – July 10, 2017**

(draft minutes)

The July 10, 2017 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Koerner, Treasurer Doyle, Trustee Reed and Trustee Thelen. Guests present were Edwin Parker, Dave White, Rashawn Schleicher, Charlene Austin, Rosalyn Smith and Diane Baclawski.

In the minutes of the June meeting, Lisa Doyle asked to amend to change the deputy treasurer to Rashawn Schleicher instead to Amy Doyle. Mike Reed seconded the amendment. Thelen moved to approve the minutes as amended. Reed seconded the motion and it passed. Thelen moved to accept the treasurer's report subject to audit. Koerner seconded the motion and it passed.

Commissioner's report: None

Public Comment: Charlene Austin appreciated the brush being cut along Bennington Rd. that was blocking the view of drivers.

Board reports: Matthews reported he had received a complaint on a couple of places on Grand River Road (a designated scenic route). Koerner shared correspondence. Doyle said the web site should be up and running by the end of the week. Bills went out for summer taxes and some are starting to come in.
